NEW BUSINESS

Susan McAuliffe asked Katie Noyd to discuss the School District-Parks and Recreation Facility Usage Contract. Jason Cole arrives at 7:09 pm. Katie said that the contract is the same as last year's contract except for the removal of the Parks and Recreation paying for the electrical at the Concession Stand and the Water Meter. The Tennis Courts electrical has remained for this year. Discussion about lights at the tennis courts and nightly time limits. There have been a few complaints but the consensus is to not put a limit at this time.

Reggie St. John brought up a few issues/typos with the contract. He wondered if it was necessary for the statement on Page 3, #6 under the School District section, "That non-compliance to any provisions may result in discontinuation of facility use." The sentence on Page 4, #1 should read, "Parks and Recreation will track hours throughout the year and supply to the School District a subtotal of hours used each month for quarterly billing purposes."

Scott Smith questioned how much responsibility or liability do we have when we are using the building if there is damage. Katie stated that it is few and far between and there

are multiple cameras to check on if things were damaged during the time when Parks and Rec is occupying the space.

Sherri Branson-Hurt asked if all coaches are aware of emergency procedures at facilities. Katie stated that all supervisors (who are there at indoor practices and games) have an emergency action plan for basic emergencies. Katie will talk to Joe Greim, Excelsior Springs High School Activities Director, about how we can keep everyone informed.
